Jan Braathu

Ambassador Jan Braathu is the sixth OSCE Representative on Freedom of the Media, appointed in December 2024. Prior to his appointment, Braathu served as Head of the OSCE Mission to Serbia from January 2021 to December 2024 and Head of the OSCE Mission in Kosovo from October 2016 until December 2020. Previously, he was Norway's Ambassador to Kosovo and Albania, and Ambassador to Bosnia and Herzegovina. His other assignments have included serving as Deputy Director General and Head of the Division for Western Balkan Affairs. Braathu also served in the Norwegian Foreign Ministry's OSCE Chairpersonship-in-Office Section from 1998 to 2000. He held the role of First Secretary and Acting Counsellor for Economic Affairs at the Royal Norwegian Embassy to the Court of St. James's from 1993 to 1996. He was also First Secretary at the Royal Norwegian Embassies in Kuwait and Saudi Arabia from 1990 to 1993.



**Julia Haas** 

Julia Haas is Adviser to the OSCE Representative on Freedom of the Media, leading the Office's work on healthy online information spaces. Focusing on internet and AI governance and digital participation, she puts particular emphasis on the impact of artificial intelligence on freedom of expression, digital and legal safety of journalists, gender and online pluralism. Previously, she worked as legal officer and human rights adviser at the Austrian Foreign Ministry. Julia is a David Rockefeller Fellow at the Trilateral Commission, sits on the advisory board for the Vienna Forum for Democracy and Human Rights, and acts as judge at the Oxford University's Price Media Law Moot Court. She holds a Master's degree in Law from the University of Vienna and an Information and Media Law LLM. In 2023, she received the OSCE Gender Focal Point award.



Claire Haering

Claire Haering is a Project Assistant in the Office of the OSCE Representative on Freedom of the Media, and works on the project "Healthy Online Information Spaces". She focuses in particular on the impact of new technologies and (generative) AI on freedom of expression and freedom of the media online. Tanja Fachathaler

Courtney C. Radsch, PhD, is Director of the Center for Journalism and Liberty at the Open Markets Institute and a nonresident fellow at Brookings. As a global thought leader on the intersection of technology, media, and rights, her research and analysis have been published in leading media outlets and scholarly journals and she earned a spot on the list of 100 Brilliant Women in AI Ethics. She has testified before congressional, parliamentary, and competition authorities around the world and advised publishers and journalism leaders about how tech and AI impact journalism, media sustainability and human rights around the world.



**Begaim Usenova** 

Begaim Usenova is the Director of Media Policy Institute in Kyrgyzstan. She is an expert in media law, media freedom, and media literacy in Central Asia. With over a decade of experience, she has conducted research, legal analysis, and provided policy recommendations on the development of independent journalism and media literacy in Kyrgyzstan. A strong advocate for public interest journalism, Begaim has focused particularly on the impact of online harassment of journalists, exploring how such threats undermine press freedom and the safety of media professionals, especially women journalists. Through collaboration with international organizations, state institutions, and civil society, she plays an active role in shaping media policy to strengthen press freedom amid growing challenges and threats to independent journalism.

She previously led the Google News Lab in the Asia-Pacific region and was an investigative reporter and data editor at Reuters, where she was a 2017 Pulitzer finalist in the national reporting category. Earlier, she was a reporter at the South China Morning Post in Hong Kong and the Times Union in Albany, New York and taught data-driven investigative journalism at the University of Hong Kong and Chinese University of Hong Kong.



Paula Miraglia

Paula Miraglia is the founder and CEO of Momentum – Journalism & Tech Task Force. She is also the co-founder and publisher of Gama Revista. She co-founded and directed Nexo Jornal for eight years. Paula holds a Ph.D. in Social Anthropology from the University of São Paulo (USP), where she also completed her master's and undergraduate studies in Social Sciences. She is a Sulzberger Fellow at Columbia University. Paula has held leadership roles in international organizations and served as a consultant for the World Bank and the Inter-American Development Bank. She serves on the boards of the Center for News Technology and Innovation, the International Press Institute, Instituto de Referência Negra Peregum, Brazilian Platform for Biodiversity and Ecosystem Services (BPBES) and Data Privacy Brasil.



**Amy Mitchell** 

Amy Mitchell is the founding Executive Director of the Center for News, Technology & Innovation (CNTI). Prior to this role, she served as Managing Director of News and Information Research at the Pew Research Center. In her 25 years with Pew Research, Amy helped launch the journalism research program and served as managing director since 2010, responsible for the center's research related to news and information, including how the public accesses, engages with and creates news, what news organizations are providing, and the evolving role of technology in the flow of news and information. Amy is an expert in project design & management, methodological application & evaluation, analysis and writing, and is a graduate of Georgetown University in Washington, D.C.

**Klaus Unterberger** 



**Deniz Wagner**

She is currently a consultant at the Office of the OSCE Representative on Freedom of the Media, conducting their work on media freedom, democracy and security. Deniz led the OSCE's first project on Artificial Intelligence and Freedom of Expression, was rapporteur to the OSCE Advisory Group of Eminent Experts on Freedom of the Media, and author of the OSCE book 'Can there be Security without Media Freedom?'. She has directed projects establishing independent oversight bodies for the media industry, supported legal reform to enhance media pluralism in Europe, and developed human rights-based guidance to addressing disinformation in the digital age. Previously, Deniz worked in strategic communications, and was a Senior Adviser for Human Rights at the Austrian Ministry for Europe, Integration and Foreign Affairs.



Max van Drunen

Max van Drunen is a postdoctoral researcher at the Institute for Information Law, University of Amsterdam. His research focuses on the regulation of technology used to create or distribute news and other public interest content, and combines law with communication and computer science. To that end he has researched how AI companies' control over technological infrastructure threatens media freedom, what responsibilities platforms and media organizations take on when they personalize the news people see, and how researchers can be guaranteed effective access to the data the need to scrutinize platforms. At present, he is collaborating in a Horizon project building a digital twin of social media platforms to allow regulators to test regulatory interventions and assess risks regarding disinformation, hate speech, and journalism.



Gülsin Harman

Gülsin Harman is an Istanbul-based journalist who frequently contributes to the New York Times and the BBC Monitoring's coverage of Turkey and the surrounding region. Her research on journalism ecosystems includes a report on the sustainability, innovation and impact of digital independent media in the country. Ambassador Jan Braathu is the sixth OSCE Representative on Freedom of the Media, appointed in December 2024. Prior to his appointment, Braathu served as Head of the OSCE Mission to Serbia from January 2021 to December 2024 and Head of the OSCE Mission in Kosovo from October 2016 until December 2020. Previously, he was Norway's Ambassador to Kosovo and Albania, and Ambassador to Bosnia and Herzegovina. His other assignments have included serving as Deputy Director General and Head of the Division for Western Balkan Affairs. Braathu also served in the Norwegian Foreign Ministry's OSCE Chairpersonship-in-Office Section from 1998 to 2000. He held the role of First Secretary and Acting Counsellor for Economic Affairs at the Royal Norwegian Embassy to the Court of St. James's from 1993 to 1996. He was also First Secretary at the Royal Norwegian Embassies in Kuwait and Saudi Arabia from 1990 to 1993.

Natali Helberger is Distinguished University Professor for Law and Digital Technology, with a Special Focus on AI, at the University of Amsterdam, and member of the board of directors of the Institute for Information Law (IViR). She is one of the founders and co-director of the AI, Media and Democracy Lab, an ELSA Lab that together with media and societal partners explores how AI can contribute to a diverse and healthy public sphere and the democratic role of the media. She is also the Scientific Director of the Dutch Algosoc Program – Public Values in the Algorithmic Society – a ten-year, interdisciplinary program into public values and automated decision making. In the past, Helberger has been member and rapporteur for the Council of Europe Expert Committees on Resilience in Journalism and Freedom of Expression and AI. Currently, she is still involved in an Expert Committee on Generative AI and Freedom of Expression and part of an expert group that assists the European AI Office in drafting a Code of Conduct for Generative AI under the European AI Act.

Dr. Anya Schiffrin is the director of the technology and media specialization at Columbia University's School of International and Public Affairs and a senior lecturer who teaches on global media, innovation and human rights. She received her PHD from the University of Navarra, after writing a dissertation on the subject of solutions to online mis/disinformation. She is the editor of both *Global Muckraking* (New Press 2014) and *Africa Muckraking* (Jacana 2016) which are collections of investigative reporting in the global south that go back more than 150 years. She's edited three volumes on the subject of media capture including *Media Capture: How Money, Digital Platforms and Governments Control the News* (Columbia University Press 2021). Of late, she's been looking at government policies to support journalism as well as platform remuneration laws and the role of philanthropy. She is an internationally known expert on AI and journalism, advocating for payments to media outlets whose content is circulated by AI firms as well as social media platforms.

As the Policy Director at the Forum on Information and Democracy, Katharina leads the development of cuttingedge policy recommendations to ensure democratic safeguards in the global information space. She also manages the engagement with the 56 States of the Partnership for Information and Democracy. She is a specialist on media freedom, information integrity and artificial intelligence. Previously she worked as a Policy Analyst on Open Government at the OECD and at Décider Ensemble.
